

First 5 Monterey County FY 2012-13 Client-Level Data Book

Introduction

Client and service delivery data have been organized into three distinct groups (listed below is a brief description for each). Whenever possible, FY 2012-13 data is compared to FY 2008-09 data (or the earliest year in which similar data were collected and entered into Persimmony, F5MC's management information system) to show changes over time.

Group 1: provides information on *unduplicated/consented clients*. Generally, these data are collected for clients receiving intensive services (e.g., playgroups, home visits, intensive consultations and therapy, technical assistance) that lend themselves to systematic and ongoing collection of unduplicated, client-level data. Group 1 data are considered the most accurate available since clients that fall into this group are consented to the evaluation by funded partners who regularly collect standardized client and service delivery data.

Group 2: provides information on *aggregate data/non-consented clients*. Many programs collecting data within this group collect aggregate versus unduplicated data because they tend to provide less intensive, one-time services (e.g., 2-1-1, emergency funding, etc.) that may not lend themselves to systematic and ongoing collection of data at the client level.

Group 3: provides basic information collected at *F5MC-sponsored community events* and through the dissemination of *First 5 Parent Kits*.

Data tables in this databook

A portion of the exhibits in this databook contain a percentage of missing and unknown data, in some instances, demographic data tables contain *adjusted percents* rather than *total percents*. The calculations for these figures omit participants reported as unknown or missing and thus portray the characteristics of participants for whom demographic data was reported. For certain characteristics (e.g., level of education and health insurance status) the large number of missing or unknown data comes from services with a one-time interaction (e.g., a class or screening) where it is deemed too intrusive to ask participants for a complete demographic profile. Therefore, these kinds of services primarily collect data in aggregate and not on an individual, client-level basis.

**6,382 more parents were served by programs that collect aggregate data from non-consented clients in FY 10-11. The majority of that increase can be attributed to parents served by the Food Bank (n=5,088) as part of F5MC's emergency funding.

***In FY 11-12, the majority of the increase can be attributed to the parents that attended Wonder of Learning (n=8,973).

****In FY 12-13, the decrease in total numbers served can be primarily attributed to programs that were no longer funded. There were also 489 people who participated in seminars. These participants are not included in the total due to lack of demographic data.

*During FY 10-11, 5,798 more children were served by sponsorships and/or parents compared to FY 09-10. Of those children served during FY 10-11, 5,373 children participated in community sponsorships while 4,962 children were served by parent kits.

**During FY 12-13, parent kits were included with "parents" for this first time. They were previously included with "children" or not at all. In FY 11-12, 4,437 children were served by parent kits. In FY 12-13, 5,315 parents were served by parent kits.

***In FY 12-13, part of the increase can be attributed to more sponsorship events compared to previous years and high estimates of participation, e.g., First Night Monterey (3,200 children and 1,800 parents), Greenfield Harvest Festival (3,000 children and 2,000 parents), Día del Trabajador Agrícola (810 children and 1,500 parents), etc.

Exhibit 9. Health Insurance Status of Children

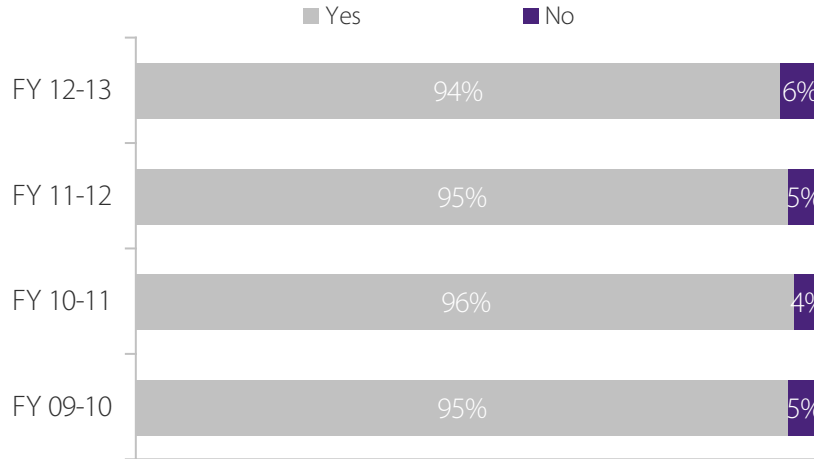
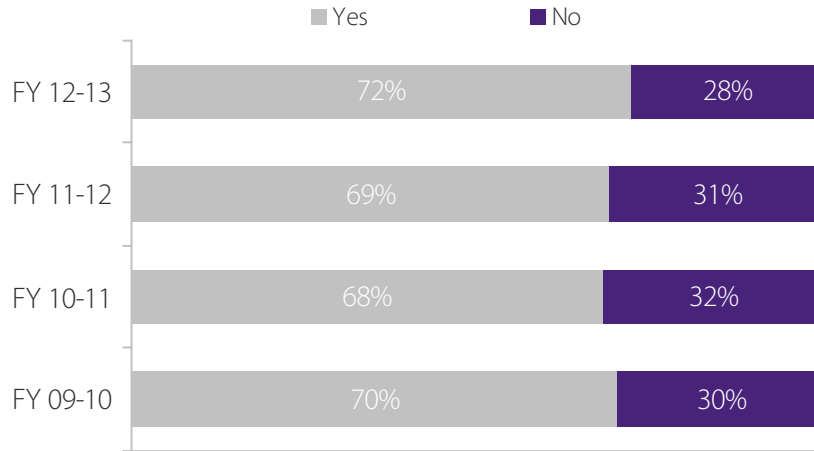


Exhibit 10. Health Insurance Status of Parents

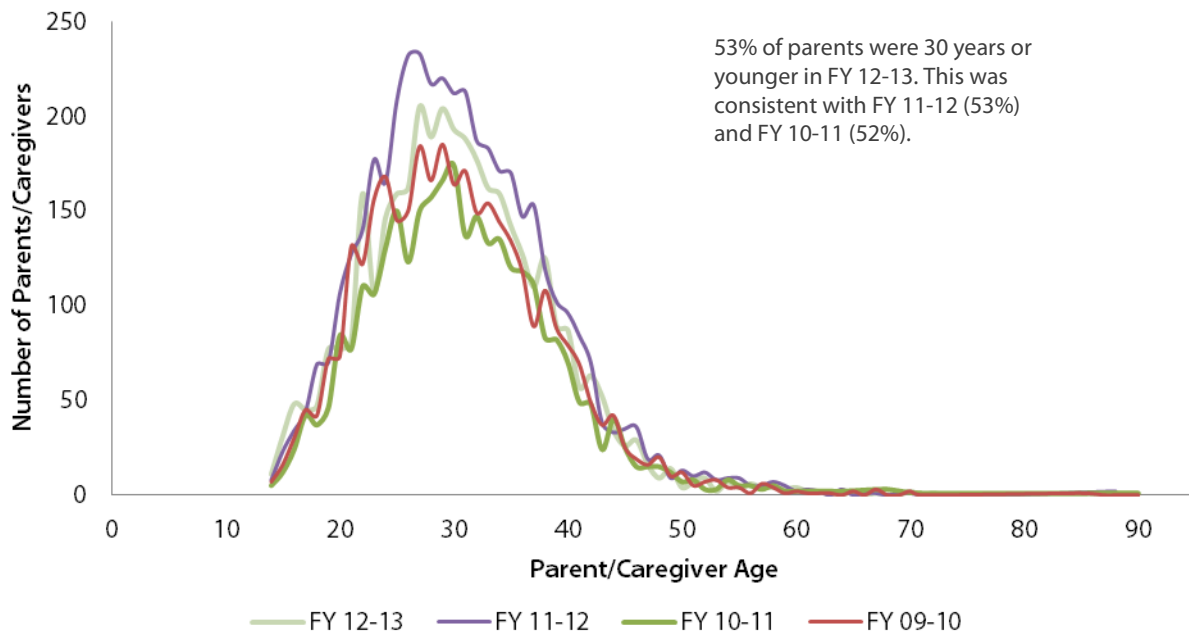

Exhibit 38. Parents Served by Region and Zip Code FY 2012-13

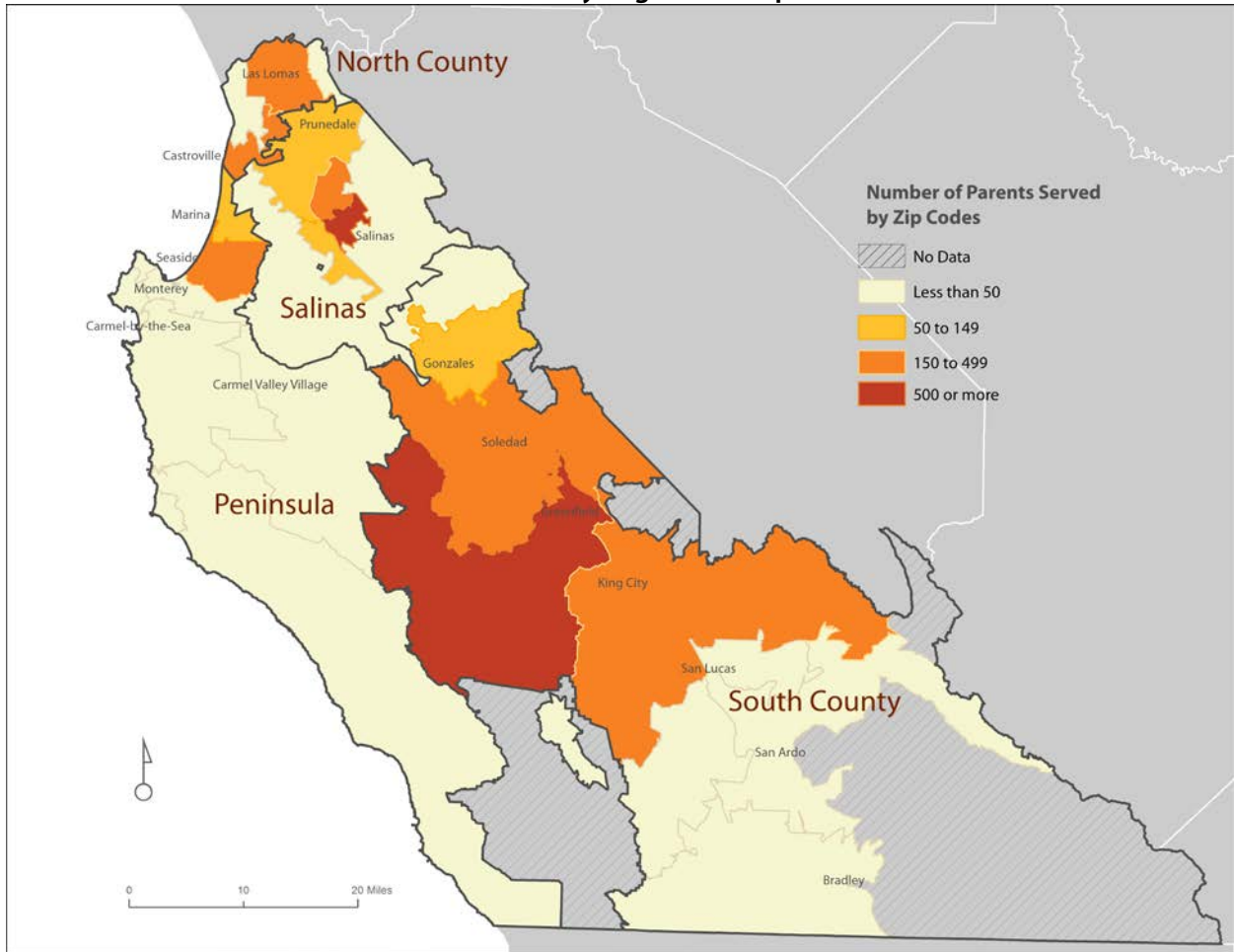


Exhibit 39. Parents Served by Region and Zip Code FY 2011-12

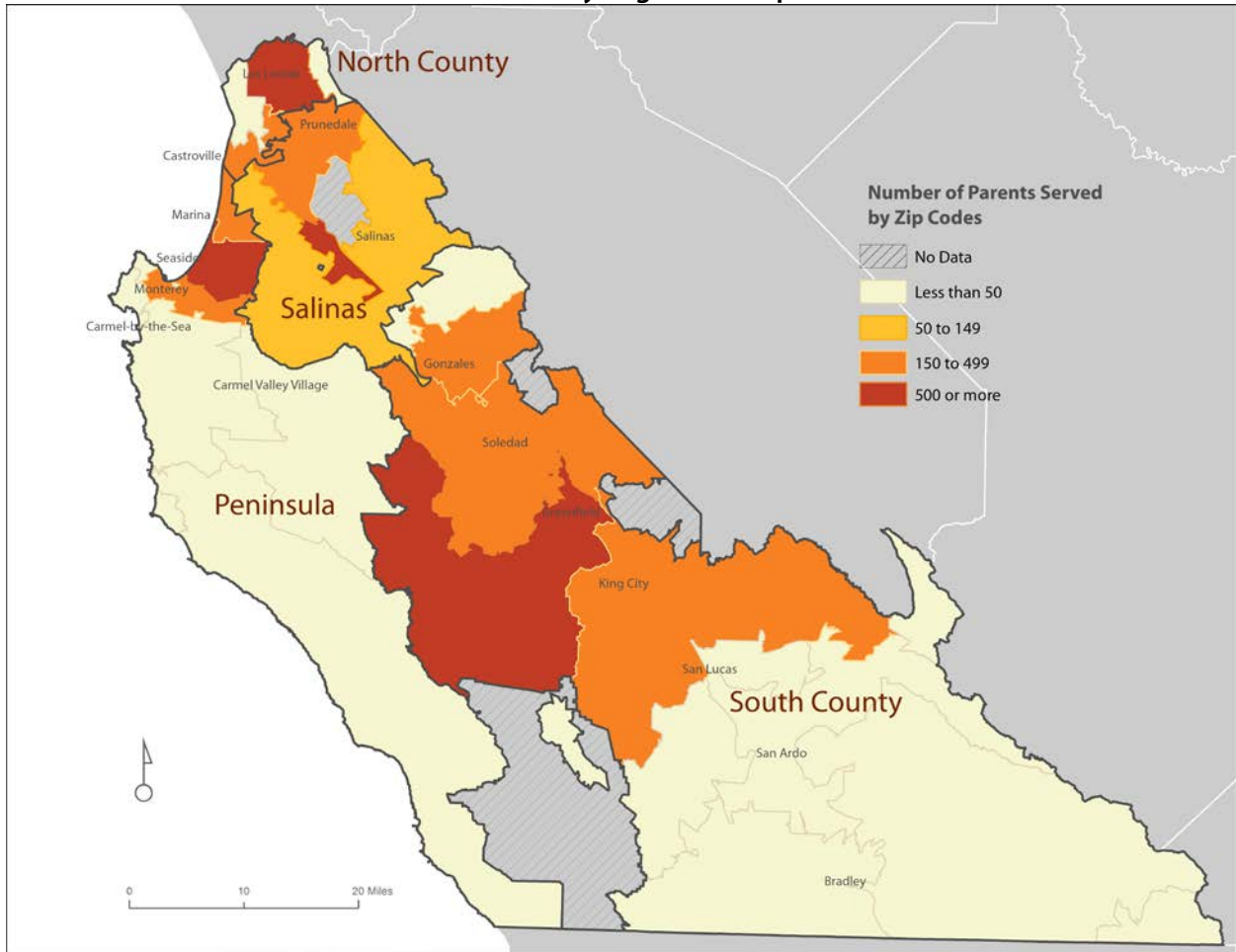
